The Course

Thank you for choosing Palm Meadows as an option for your Corporate Golf Day.

Palm Meadows Golf Course at Carrara on the Gold Coast is centrally located within 10 minutes drive of Surfers Paradise and five minutes from Broadbeach.

Palm Meadows welcomes golfers of all standards.

The all weather golf course has 11 kilometres of golf cart paths around the fairways.

Palm Meadows has a fleet of 72 Club Car electric golf carts each with its own esky and latest GPS technology.

The challenging 350 hectare course was designed by leading Australian golfer

Graham Marsh. Par 72 measures 6319 metres off the championship tees. Water comes into play on 14 holes and there are 82 sand bunkers.

The first hole is recognised as one of the world's most challenging opening holes.

Water runs the length of the hole on the left and the world famous bamboo curtain forms a barrier to the right.

Palm Meadows signature hole is the world famous 18th; it measures 523 metres from the championship tees. Players accept the challenge and decide how

much of the right dogleg they want to cut off. American Golf Digest rated Palm Meadows 18th in the world's top 500 golfers.



Corporate Golf

Palm Meadows can host golfing events for both social and corporate groups of up to 128 people for any occasion.

Green Fees

The 2017 rate for all Corporate Golf Days and groups of 16 players or more is **\$55 per player** midweek and **\$59.50 per player** weekends which includes 18 Holes and a shared electric cart.

A half day hire of **\$5500** is also available for either a morning or afternoon shotgun start.

Terms and Conditions

1. Taxes & Services Charges

All rates are quoted in Australian Dollars (\$AU) and include GST. Palm Meadows Golf Course (PMGC here on in) reserves the right to adjust rates/charges agreed to within the agreement period, in the event of any Tax alterations by the government.

2. Confirmation, Cancellations & Wet Weather

All bookings require a \$200 deposit, which is to be paid within 14 days of booking. Function details are required to be confirmed 14 days prior to event date including timings, menus, security and any other special requirements.

The client may cancel the function by written notice to PMGC on the following terms:

If notice is received 30 days prior to the function, the client will be reimbursed the full deposit.

If notice is received 14 days prior to the function, the client will be reimbursed 50% of the deposit

If notice is received less than 7 days before the function, the client forfeits the full deposit.

In the event of the Course being closed due to wet weather, the deposit will be fully refunded or credited to a future booking.

3. Guaranteed Numbers

PMGC provides quotations based on the estimated number of guests to any one function and the quote is subject to change. An educated estimate of guests is requested 14 days in advance of the function date. A guaranteed (confirmed) number of guests attending the function is required 3 days prior to the event. Charges will be rendered according to the number of people attending the function or the guaranteed number whichever is greater.

4. Payment

Further to the initial holding deposit, a Tax Invoice will be issued 2 days prior on the day with the balance of payment required at the completion of the day. Payment can be made by Company Cheque or Credit Card. Account facilities can be arranged by request and are subject to approval, upon completion of a Credit Card Application Form.

5. Damage, Conduct & Insurance

The Client must conduct the Function in an orderly manner, in full compliance with the Terms & Conditions and ensure compliance by all persons in attendance with the same. The Client must ensure no disturbance or nuisance will be caused to PMGC or any of its guests, visitors, staff or neighbours. The PMGC is entitled to remove any persons from the Function whose behaviour, in the opinion of PMGC, is objectionable, improper or undesirable. Any property of the client or any other person, brought into PMGC shall be at the owner's risk and PMGC shall not be liable for any loss or damage, however caused. This includes all and any items left after the event. The client is liable for any damage or destruction to PMGC property by any invitee of the Golf Day. All invitees are the responsibility of the client.
