TERMS AND CONDITIONS

TAXES & SERVICES CHARGES

All rates are quoted in Australian dollars (\$AU) and include GST.
Palm Meadows Golf Course (PMGC) reserves the right to adjust rates/charges agreed to within the agreement period, in the event of any tax alterations by the government.

2. CONFIRMATION, CANCELLATIONS & WET WEATHER

All bookings require a \$1000 deposit, which is to be paid within 30 days to confirm the booking.
Function details are required to be confirmed 14 days prior to event date including timings, menus, security and any other special requirements.

The client may cancel the function by written notice to PMGC on the following terms:

- *If notice is received 30 days prior to the function, the client will be reimbursed the full deposit.
- *If notice is received 14 days prior to the function, the client will be reimbursed 50% of the deposit
- *If notice is received less than 7 days before the function, the client forfeits the full deposit.

In the event of the course being closed due to wet weather, the deposit will be fully refunded or credited to a future booking.

GUARANTEED NUMBERS

PMGC provides quotations based on the estimated number of guests to any function and the quote is subject to change.

An estimate of guests is requested 14 days in advance of the function date.

A confirmed number of guests attending the function is required 5 days prior to the event.

Charges will be rendered according to the number of people attending the function or the confirmed number, whichever is greater.

PAYMENT

Further to the initial holding deposit, a tax invoice will be issued 5 days prior to the day with the balance of payment required 3 days prior to golf day.

Payment can be made by company cheque, credit card or direct deposit.

Account facilities can be arranged by request and are subject to approval, upon completion of a credit card application form.

DAMAGE, CONDUCT & INSURANCE

The client must conduct the function in an orderly manner, in full compliance with the terms & conditions and ensure compliance by all persons in attendance with the same.

The client must ensure no disturbance or nuisance will be caused to PMGC or any of its guests, visitors, staff or neighbours.

PMGC is entitled to remove any persons from the function whose behaviour, in the opinion of PMGC, is objectionable, improper or undesirable.

Any property of the client or any other person, brought into PMGC shall be at the owner's risk and PMGC shall not be liable for any loss or damage, however caused,

this includes all and any items left after the event.

The client is liable for any damage or destruction to PMGC property by any invitee of the golf day.

All invitees are the responsibility of the client.

ADDITIONAL INFORMATION

PMGC is a fully licensed venue, therefore NO BYO alcohol is permitted on the grounds, inclusive of sponsored holes.

Any marquees, banners, signage etc set up on course for a corporate golf day will not be available for collection until midday the following day.
